17	SECTION 1. A new section of the Public Assistance Act is
18	enacted to read:
19	"[ <u>NEW MATERIAL</u> ] MARKET ASSESSMENTS REQUIRED
20	A. By July 1, 2026 and every two years thereafter,
21	the authority shall conduct a market assessment to determine
22	the regional average commercial insurance reimbursement rate
23	for all health care services provided in Arizona, Colorado,
24	Utah, Oklahoma and Texas that are covered by the New Mexico
25	medicaid program.

The medicaid reimbursement rate for all health 2 care services that are covered by the New Mexico medicaid 3 program shall be the greater of: 4 two hundred percent of the medicare (1) 5 reimbursement rate for the equivalent service; or 6 (2) the regional average commercial insurance 7 reimbursement rate for the service. 8 Using the medicaid reimbursement rate for each C. 9 health care service as of July 1, 2024 as a baseline for 10 comparison, all health care entities that receive increases in 11 medicaid reimbursement pursuant to this section shall ensure 12 that at least seventy-five percent of the increase in 13 reimbursement revenue is used to: 14 provide increased compensation to health (1)15 care workers and other employees who interact directly with 16 patients; or 17 hire additional health care workers and (2) 18 other employees who interact directly with patients. 19 D.
